GUIDANCE NOTES

These interests include the name of their employer, the addresses of any land within the district in which the Councillor/Non elected Member has a beneficial interest, or a licence to occupy; interests in companies and securities in which they have substantial interests which operate in the district and other financial interests.

As well as their own interests, the interests of their spouse or partner or the person with whom they live with as a spouse or partner must also be declared. If you do not know the interests of your spouse or partner, please mark the form "Not Known"





Definitions

For the purposes of the Register of Interests above the following definitions apply

"relevant person"	Means you or your spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you were civil partners
"securities"	Means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
