GUIDANCE NOTES

(a) that body, to your knowledge, has a place of business or land in the area of the Council, and
(b) either:-

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the Relevant Person has a beneficial interest exceeds one hundredth of the total issued share capital of that class, including the name of any such body.

(d) Any contract which is made between the Relevant Person (or a body in which the Relevant Person has a beneficial interest) and the Council under which goods or services are to be provided or works are to be executed and which has not yet been fully discharged, including a description of any such contract.

For the purposes of the Register of interests above the following definitions apply

"relevant person"	Means you or your spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you were civil partners
"securities"	Means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
