### GUIDANCE NOTES

These interests include the name of their employer, the addresses of any land within the parish in which the Councillor/Non elected Member has a beneficial interest, or a licence to occupy; interests in companies and securities in which they have substantial interests which operate in the parish and other financial interests.



**Definitions**

For the purposes of the Register of Interests above the following definitions apply

"relevant person"	Means you or your spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you were civil partners.
"securities"	Means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
