GUIDANCE NOTES

Members of the public are required by law to declare interests when they become a Councillor or non-elected Member. As well as their own interests, the interests of their spouse or partner or the person with whom they live as a spouse or partner must also be declared. If you do not know the interests of your spouse or partner, please mark the form "Not Known".



"securities"	Means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
