**GUIDANCE NOTES**

Members of the public are required by law to declare interests when they become a Councillor or non-elected Member. "securities"	Means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
